### ENDOWMENT FUND PARTICIPATION AGREEMENT

This Endowment Fund Participation Agreement is entered into between the Catholic Diocese of Wichita, a Kansas Not For Profit Corporation, “Diocese” and

The Catholic Diocese of Wichita has established an endowment program to allow various diocesan parishes, schools, agencies and entities to form and participate in the endowment program to provide for future long-term financial needs and designated purposes. The Entity hereby expresses its intention to participate in the endowment program of the Diocese. The Diocese hereby confirms and accepts the Entity as a member with a participating endowment in the endowment program.

As a participating member, the Entity will share in a common pooled investment fund. Contributions by the Entity will be placed in a separate Entity fund within the pooled investment fund and will be accounted for in the name of the Entity. Management and investment of the account assets will be subject to the Catholic Diocese of Wichita Statement of Investment Policy, Objectives and Operating Guidelines.

It is understood that withdrawals from the Entity fund will be permitted in accordance with the provisions of Endowment Policy of the Catholic Diocese of Wichita.

In exchange for the administrative services rendered by the Diocese, an annual administrative fee will be assessed for the management of the assets of the endowment. This fee is currently 0.25% annually of each fund balance and is periodically reviewed.

It is understood that both the Catholic Diocese of Wichita and the Entity will hereby follow the spirit of the endowment program and abide by the policies and procedures as have been established.

The Catholic Bishop, Ordinary, and Pastor of the Catholic Diocese of Wichita, after appropriate due process and consideration in accordance with Canon and Civil law, will serve as the final authority to resolve all matters requiring further consideration and ultimate determination not previously covered in the above documents governing this agreement.

The ENDOWMENT FUND OPERATING POLICY is (Exhibit B) is considered part of this Participation Agreement.
